

## **CAMPING RULES**

Faith Convention 2025

### **A. ENTERING AND REMAINING IN THE CAMP SITE**

1. Only those registered and their staff are authorised to enter the area reserved for camping.
2. When checking in, campers must present the Citizen Card or Passport used when registering on the platform. Only valid documents corresponding to the data registered will be accepted.
3. Whenever entering the site reserved for camping, campers must present the personal, non-transferable camper's wristband purchased at check-in.
4. Animals are not allowed on the site.
5. Visitors are not allowed, except in the case of parents of minor children who are staying at the campsite. In these cases, the visit must be notified in advance by the campsite reception team.
6. Campers may use not only the space set aside for tents, but also the entire Quinta da Ribeirinha site, except for the reserved areas and workplaces, which are properly signposted.
7. During your stay at the campsite, you must respect the curfew set for 02h00. All campers must keep quiet and avoid disturbing others after this time.
8. After 2am, no entry to the campsite will be permitted. From that time onwards, any kind of noise or activity will be prohibited, ensuring the tranquillity and rest of all campers.

Note: The area set aside for camping will be monitored to ensure the safety and well-being of all campers.

### **B. RESPONSIBILITIES**

1. ALL PARTICIPANTS (CAMPERS AND COLLABORATORS) ARE RESPONSIBLE FOR THE GOOD OPERATION OF THE CAMPING AREA.
2. It is not permitted to accumulate rubbish or to throw rubbish on the ground or in neighbouring yards. The entire site will be equipped with identified rubbish collection points.
3. vehicles may not be parked within the space reserved for camping tents.  
(Vehicles may only enter for the minimum period necessary for loading and unloading)

4. Campers must collaborate to ensure the good condition and cleanliness of the changing rooms, barbecue areas and sinks.
5. The Organising Committee IS NOT RESPONSIBLE for the disappearance or deterioration of any objects, including equipment or electronic devices belonging to campers, as EVERYONE IS RESPONSIBLE for their belongings.
6. There must be no fires or bonfires of any kind
7. When camping, as a courtesy to the other brothers, we should, if possible, leave the toilets clean.
8. It is important to save water and electricity as much as possible.
9. Appliances that exceed 500W should not be switched on (toasters, irons, hair straighteners or hair dryers, etc).

### **C. OTHER INFORMATION**

1. The organisation defines the location of the tents in the park.
2. Acceptance of camping registrations is subject to approval by the organisation.
3. Campers who engage in inappropriate behaviour that jeopardises the smooth running of the park will immediately be asked to leave the site, including rented rooms.

Examples of inappropriate behaviour:

- 1- Acts of vandalism, misconduct or disrespect for the silence after curfew
- 2- Damage or destruction of park facilities, including toilets, common areas, tents, accommodation and rooms
- 3- Lack of respect for park staff and non-compliance with established rules and instructions.
- 4- Failure to present identification or proof of registration at the park, whenever requested by.
